

INTRODUCTION

1 Project Background

Uttar Pradesh has a road network of 299,604 Km, out of which 174,451 Km is under Public Works Department (PWD). The roads under PWD comprise 7,550 Km of National Highways (NHs), 7530 Km of State Highways (SHs) 5,761 Km of Major District Roads (MDRs), 3254 Km of Other District Roads (ODRs) and 138,702 Km of Village Roads (VRs). Only about 60% of SHs are two-lane (7 m). In the entire state 62% of MDRs and 83% of ODRs have widths less than 7m.

With a view to improve the Transport Network System, UPPWD has identified 24,095 Km of Core Road Network for the development. This network comprises of NH, SH, MDR, ODR and the details are presented in the table below:

2 Project Overview

The Civil Works component has been taken in two Phases. The Terms of Reference (TOR) for consultancy contract identifies roads with an aggregate length of 419 Km as Phase-I and remaining roads to be undertaken under Phase-II. The total budgeted Project Cost is about INR 3,500 Crore, out of which funds available for the works has been estimated at about INR 3,000 Crore.

Public Works Department (PWD) on behalf of Government of Uttar Pradesh engaged M/s Egis India Consulting Engineers Pvt. Ltd. to carry out Consultancy Services for Uttar Pradesh Core Road Network Development Plan. The Consultant is required to provide all required assistance and support to the PWD /GoUP/ Bank Task Team in complying with World Bank Investment Project Financing Policies and Procedures.

The Project Management Consultancy services will be undertaken in three Parts.

- **PART A:** Project Preparation including Detailed Engineering Design and Contract Documentation (Lump Sum) 24 months from commencement of services.
- **PART B:** Construction Supervision of Phase I Civil Works (Time Based) Until completion of Civil Works of Phase-I roads including DLP & Maintenance (24-30 months + 60 months Maintenances period including DLP)
- **PART C:** Project Management Services (Time Based) Initially for 5 years further extension based on Consultants performance.

The Contract was signed on 8thAugust 2014 and it was agreed that the start date for the assignment shall be considered as 19thAugust 2014. The initial discussions were held on 14thAugust 2014 with Client on the priority roads and scheduled deliverables. Accordingly, the teams were mobilized and activities commenced on Proposed Phase-I roads.

This **Monthly Report No. 37** is prepared and submitted with respect to Terms of Reference (TOR) for Consultancy Services to Agreement between the Chief Engineer (EAP), Uttar Pradesh Public Works Department (UPPWD) and Egis India Consulting Engineers Pvt. Ltd, New Delhi.





- ➤ Site visit carried out by the Team Leader Mohd. Ayaz Beg & Resident Engineer Mr. Anjani Kumar on dated 06.07.2022 and Inspection and Observations Report issued to the Contractor for compliance vide Egis letter No. Egis India/LKO/UPCRNDP/2022/1863 Dated 12.07.2022.

vii. Key Issues

- ➤ Contractor strictly instructed to ensure that the 2 Nos. Toilet Blocks at Truck Lay Byes must be functional 24X7 with running water and Power.
- ➤ At Ch. 139+600, the Jal Nigam Department is constructing a box culvert for irrigation canal crossing by demolishing the newly constructed road. This has been intimated to the Authority and to the Concerned Department of UP Govt. for further necessary action. The Excavation by External Agency is up to 15m in depth, which causes disturbance to the





adjacent part of the Project Road. The Road Project Contractor of UPPWD will NOT be responsible for maintenance of this section of road, which has to be maintained by the Irrigation Dept. and a MOU has been agreed by all parties. The AE has written to the Client expressing the safety concerns due to embankment height increased to almost 15 mtrs and therefore, the Irrigation Department Contractor must provide all safety measures for this section of road to prevent fatal accidents.

- ➤ The Contractor has taken temporary measures to seal the Longitudinal minor Cracks developed in the paved shoulder from ch.120+800 to ch.124+650 for which the Contractor to submit methodology and sealant material for permanent repair.
- ➤ Metal Beam Crash Barriers have not been connected with RCC Crash Barriers at Bridge locations. Contractor has to connect the MBCB to RCC Crash Barriers as soon as the connectors are delivered to prevent any accidents. In the meantime the Contractor instructed to immediately place sand bags with reflective tape at these locations.
- ➤ Concrete Crash Barrier painted over by Local Residents at many locations to be repainted black and white as per Contract requirement for structure visibility for safety of road users.
- Local residents dumped building material on road side and footpath, instructed Contractor to inform Police/Client/PMC immediately to prevent serious accidents.

The Contract Agreement No.115/UPCRNDP/UPG/01/2019-20 was signed on 19thJune 2019 and the EPC Contract Amount is of **INRs 262,39,50,000/-** (Rupees Two Hundred Sixty-Two Crore Thirty-Nine Lac Fifty Thousand Only). The Revised Completion cost of Project of Civil Works is of **INRs. 275,65,00,741/-** (Rupees Two Hundred and Seventy-Five Crore Sixty-Five Lakhs Seven Hundred Forty-One Only). - ➤ 02 Nos. Toilet Blocks at Truck Lay byes have not been constructed as local residents are objecting to the location shown on the approved drawings and therefore, the Contractor is discussing with the Authority representative for alternative locations.
- > The 2 Nos. Completed Toilet Blocks must be fully functional and cleaned regularly by the Contractor.
- ➤ During O&M work Additional flagmen to be provided at work zone/diversion on live carriageway and all safety items such as water filled Plastic Barriers and advance signs to be maintained during the maintenance work and Contractor to take approval from AE for any lane closures of the live carriageway as per Clause 14.5 of the Contract Agreement.
- ➤ All Planted tree saplings to be watered regularly and the Contractor instructed to replace those which have died and balance saplings to be planted ASAP.
- ➤ Three Irrigation canal crossings by UP Irrigation Department with Bridge/Box Culverts have been completed and the pavement reinstated at three crossings, however, concerns expressed of quality of work as per UPPWD standards. The fourth Irrigation canal crossing under progress and expected to be completed by end of August 2022. Maintenance of these sections will be the responsibilities of the Concerned Authority as the works were carried out by Irrigation Department Contractor after completion of the road by UPPWD Contractor.
- ➤ Contractor progressing to clean inlet and outlet of all structures prior to start rain and check chute drain in all high embankment area and ensuring the proper channelization to guide rain water in order to avoid any damage to the embankment during rainy season.
- ➤ Contractor to mobilize team for construction of Table top ASAP for safety of road users.
- ➤ Contractor has completed all CPR works but approval from the Authority is awaited regarding the CPR estimate approval request reminder has been given to Authority vide our letter no. Egis India/LKO/UPCRNDP/2022/1866 Dated 15.07.2022.

24. SOCIAL MONITORING AND COMPLIANCE REPORT

INTRODUCTION

The current report is the monthly Social Safeguard Monitoring Report prepared to ensure the comply with the implementation arrangements agreement between World Bank and UPPWD. The main objective of this report is to brief the Land Acquisition and resettlement implemented across all the packages during the construction period.

The resettlement activities were achieved in all Four Packages of Phase-I Roads.

- ➤ Only one namely UPG-03 was required land acquisition. In UPG-03 (Gola-Shahjahanpur) the land acquisition was impacted nearly 92 Title Holders (TH).
- ➤ The other packages UPG-01, UPG-02 & UPG-04 involve resettlement of Non-Title Holders only. The compensation of NTH Disbursement of Structures Compensation & R&R Assistance Squatters & Encroachers was 100% & for Kiosks also 100% was disbursed within targeted period of time for successful implementation of civil works.
- As per original calculations/estimates, 3.0375 Hectare land was required but as per the actual field condition revised land 2.781 ha was required in order to minimize negative impacts and revised nos. of TH was affected only 84 TH.
- All the resettlement planning documents related to above projects were disclosed.

RESETTLEMENT ACTION PLAN (RAP) IMPLEMENTION BY NGO

Non-Government Organization (NGO) M/s Study Point Samittee was initially appointed for implementation of RAP in Phase-I roads. However, on expiry of Contract Period the NGO's was not intended to extend his services. M/S Development Institute for Systems Alternatives (NGO) based in Lucknow was appointed to assist UPPWD to complete the remaining works of land acquisition and R&R activities. The services of above NGO awarded in under Contract No 123/1-13/UPCRNDP/CEEAP/2020 dated 21/10/2020 under IBRD- Loan No 8940-In.for implementation of Resettlement Action Plan (RAP).

All the micro plans were prepared and the Compensation of NTH Disbursement of Structures Compensation & R&R Assistance for Squatters & Encroachers is 100% & for Kiosks also 100% was disbursed.

STATUS OF CPRS

It is communicated to the UPPWD, PMC, Contractor and NGO that total 43 CPRs for which the consent as well as site has already been identified, Design-drawing and construction plan with minor corrections are approved and Construction Works Completed and all CPRs are relocated.

TRAINING AND SUPPORT FOR INCOME RESTORATION

The training programme was organized by the NGO in order to motivate and create interest among the PAPs to adopt Tool & Machinery trade as income generating livelihood and also to encourage the next future employment. The income restoration activities are completed.





CONCLUSION

This was achieved through assessment of compliance with domestic policies, legislations and procedures as well as World Bank Safeguard Policy objectives. Generally, the implementation of the Resettlement Action Plan (RAP) was complied with the foregoing requirements.

With regards to the socio-economic status of the PAPs before and after RAP implementation, the study has concluded that the there was no serious impacts on the livelihood structure of PAPs and access to land, livestock or sources of income. Similarly, patterns of social interactions remained intact. RAP implementation did not have any livelihood impacts as there was no loss of access to different public services such as schools, health facilities, sewage lines, water reticulation points, loss of access to markets, loss of access to suppliers or even support networks.




